## **ZERO TOLERANCE**

MYLA will be strongly implementing a zero-tolerance policy for the use of foul / inappropriate language, bullying, destruction of facilities, and poor sportsmanship. This includes, but isn't limited to actions towards coaches (Moorhead and opposing coaches), officials, parents (of either team), and tournament personnel. This also applies to actions taken by players digitally and/or on social media. Coaches and Players represent Moorhead and its community, and they need to act accordingly.

First Offense: Verbal warning.

**Second Offense**: Dismissal from the next game (if during a game, includes remainder of current game and next game).

**Third Offense**: Dismissal from the team, pending board decision.

If an offense is egregious enough, and the discipline needs to be elevated, MYLA and its directors have the right to do so.

## **Weather Cancellations**

The following will cancel potential games and practices:

- 1. A heat Index of 100 or more.
- 2. Too much rain, which would cause damage to the fields and put the kids at risk of injury.
  - 3. Thunderstorms/violent storms, or lightning in the area.

The City of Moorhead has the final say when it comes to field conditions and can shut us down at their discretion. Communication of cancellations will be on our social media, emails, and through a team's groupme.

# **Code of Conduct Agreement**

The code of conduct is as follows:

- Players/Parents will not use foul language on the field towards any coach, player, official, parent, spectator, or tournament official. This includes the use of any kind of slang, racial slurs, or derogatory language.
- Players/Parents will act appropriately and will respect home and away facilities.
   This includes but is not limited to: Hotel facilities, fields, restaurants, and training facilities. When our teams travel, we represent the community of Moorhead and must do so with pride and respect.
- 3. Bullying is not allowed in any way shape or form and will not be taken lightly. This includes but isn't limited to: Verbal bullying, physical bullying, and electronic/cyber bullying.
  - a. Verbal bullying: teasing, name calling, inappropriate, sexual or racial comments, taunting, hand gestures, verbal threats, mocking, etc.
  - b. Physical bullying: hitting, kicking, punching, spitting, tripping, shoving, stealing/damaging personal property, and any other way to cause physical harm to a players body or property.
  - c. Electronic/Cyber Bullying: The use of email, cell phones, social media, the internet, text messages, online game chat, and any other form of electronic device/form of communication that is used to bully another.
- 4. Players/Parents will show good sportsmanship toward their opponents.
  - a. Sportsmanship is an understanding of and commitment to, fair play, ethical behavior, integrity, and general goodwill toward an opponent. Players should be gracious when they win or lose and always treat their opponent with respect.
